MTR is a globally recognised railway company with a total operating route length of over **3,600 km** and an annual patronage of more than **4 billion** in various locations, including Hong Kong, Mainland China, Macau, Australia, Sweden and United Kingdom.

In addition to the core transportation service, MTR also involves in property development and station commercial businesses in its home market, Hong Kong. MTR owns and manages **16 shopping malls** which are equivalent to a total lettable floor area of approximately 423k sq. m., **5 office buildings**, over **42k station advertising units** and **1.6k station shops** as well as manages over **121k** residential units in Hong Kong.


